- A: Making counter publics/evidence: examples of innovative techniques to make critical issues of datafication public, and tailoring knowledges to different publics; cases of exploring forms of creating more transparency, creating better understandings and counter knowledges of the interplay of technology, practice and institutions at the border;
 - moderated by Michelle Pfeiffer
 - examples: <u>Border Forensics</u>, <u>Forensic Architecture</u>, <u>Border Violence</u> <u>Monitoring Network</u>, etc.
- **B: Making migrants' accounts on "data" or data trouble heard:** examples of grass root activists and solidarians involved in struggles and forms of resistance;
